

# **MATTERS OF CONCERN ON RECUSAL BY PRESIDING JUDGE**

**COUNTY COURT APPEAL CASE NUMBER: AP-23-XXX**

**1)** Members of Melbourne's legal profession gathered at St Patrick's Cathedral in East Melbourne on Monday 30 JANUARY 2023 for the annual RED MASS to mark the official opening of the legal year. Its name derives from the red vestments worn by the celebrants to signify the Holy Spirit and therefore has a DAY OF PENTECOST manifest affiliation.

ARCHBISHOP PETER A COMENSOLI celebrated Mass for about 160 legal representatives, including judges of the High, Federal Circuit and Family courts of Australia and the Supreme, County and Magistrates' courts of Victoria, as well as King's Counsel and Senior Counsel, solicitors and barristers from metropolitan and suburban legal firms, and members of parliament and government departments, including Australia's ATTORNEY-GENERAL, the HONOURABLE MARK DREYFUS KC MP.

The RED MASS IS ARRANGED ANNUALLY BY MEMBERS OF THE MELBOURNE CATHOLIC LAWYERS' ASSOCIATION, WHICH WAS FORMED IN 2001. Chairman of the Red Mass Committee, Mr TIM MCFARLANE said, "the RED MASS has become an important focus for Catholic lawyers as it provides an opportunity to reflect upon the year ahead and, just as importantly, also provides an opportunity to spend time together with colleagues both in prayer and socialising."

**2)** This stands in contradistinction to ourselves having by email of 1642 / 1710 HOURS ON 30 JULY 2022 served the following documents upon all state (some addressing conflation as obstruction noted) based CATHOLIC ARCHBISHOPS within the COMMONWEALTH the following documents with the advice that they ought "CEASE MAKING FALSE PUBLIC [ASSERTIONS] ABOUT PREROGATIVE CLAIMS OF RELIGIOUS BELIEF AND THE SLANDER THAT LGBTIQ PERSONS HAVE NO SUBSTANTIATED CLAIM TO PIETY SINCE THESE DOCUMENTS TO THE CONTRARY HAVE BEEN SERVED UPON YOU THIS HOLY SABBATH DAY (4TH COMMANDMENT) / SATURDAY 30 JULY 2022.

**3)** Such email then followed upon several others, but notably there was an email sent @ 1636 HOURS ON 29 JANUARY 2023 as occurring a day prior to the observation of the VICTORIAN LEGAL FRATERNITIES annual RED MASS upon Monday 30 JANUARY 2023 and the title of this email was "**SUMMARY TO OBSERVED BREACHES OF INTELLECTUAL PROPERTY BY PAPAL AUTHORITY RELATING TO RENEWAL OF KNIGHTS TEMPLARS BY PAPAL BULL MISERICORDIAE VULTUS ANNOUNCED: #449 / #503 - 13 MARCH 2015**" AS REVISION DATED 29 JANUARY 2023

And due to an identified **#264 - \*KEY\*** grounding as INTELLECTUAL PROPERTY THEFT for OBSERVED BREACHES RELATING TO RENEWAL OF KNIGHTS TEMPLAR (ie. **CHRIST OF THE RESURRECTION as per images filed within COUNTY COURT APPEAL NUMBER AP-18-0609 determined 9 DECEMBER 2019**) ON 11 APRIL 2015 it was unequivocally conveyed that all and every "ROMAN CATHOLIC ARCHBISHOPS are herewith advised that you are not permitted, whether by impetus of IRISH REPUBLICAN ACTIVISM (eg: **#373 / #298 - \*GOOD\* \*FRIDAY\* \*AGREEMENT\* 10 APRIL 1998**) or sectarian action such as the **PAPAL BULL MISERICORDIAE VULTUS ANNOUNCED: #449 / #503 - 13 MARCH 2015** to have any association with my INTELLECTUAL PROPERTY and ought to publicly FORESWEAR any continuing association.

That LEGAL ACTION will be pursued at a convenient time, related to unlawful use of my INTELLECTUAL PROPERTY within a theoretical NOUMENON / GODHEAD and SOVEREIGN / SACRED substantiation of my sapient RELIGIOUS BELIEF and same sex identity."

**4)** The enclosed **TABLE OF APPENDICES DOCUMENTS** are a progress update to our INFORMAL INVESTIGATION as that which is associated to the IBAC COMPLAINT as **CASE-2022XXXXX** formally having been lodged upon 17 JULY 2022 and relevant to continuing matters of investigation raised within the initiating COMPLAINT proper as our BELIEF that the false considerations of CATHOLIC RELIGIOUS BELIEF which are raised by an APPLICATION FOR INTERVENTION AND PERSONAL SAFETY ORDER as **CASE NUMBER L10182359** as interim orders granted 6 FEBRUARY 2020 are made to advance the CAUSE CÉLÈBRE / CAUSAE COMMUNI of IRISH REPUBLICAN ACTIVISM in conjunction to the HIJACKING of the ANZAC 2018 CENTENNIAL.

**5)** Our rationale for the **COUNTY COURT APPEAL CASE NUMBER: AP-23-XXX** which were provided to the DEPARTMENT OF PUBLIC PROSECUTIONS' (DPP) enquiry on "HOW PROCEEDING IN APPEAL AGAINST CONVICTION AND SENTENCE" as by a timely email response (3 minutes later) @ 1628 HOURS ON 23 MAY 2023, stated in ITEM #8:

That the MAL ADMINISTRATION OF JUSTICE within the COUNTY COURT APPEALS PROCESS which then obstructed any possibility of an alleviation, or an opportunity for a contested hearing against the grounds for the ORDERS or a consideration on whether they were indeed valid given evidence of unlawful activity, has been exasperated by a RESOLUTE FAILURE (ie. **in comparison the same neighbour was as a result of a domestic dispute with their fiancé, placed on a CORRECTIONS ORDER and months later was subjected to a police drug raid by a mere allegation made by the other party and the last such raid occurring on 26 MAY 2023 whilst attending by WEBEX a COUNTY**

**COURT FILING HEARING**) of the POLICE TO ACCEPT ANY EVIDENCE that the GROUNDS FOR ORDERS were fabricated to facilitate INTELLECTUAL PROPERTY THEFT and the HIJACKING of the ANZAC CENTENNIAL 2018 in the advancement of a seditious and violent IRISH REPUBLICAN ACTIVISM cause, has been made permanent a manifest of trauma, by the regrettable and slanderous circumstance of a REMEMBRANCE DAY 11 NOVEMBER 2021 CONVICTION for an alleged BREACH as **NUMBER CASE M11048888** before the actual INTERIM ORDERS as **CASE NUMBER L10182359** issued upon 6 FEBRUARY 2020 could be properly tested as an application established upon grounds that were entirely FICTIONAL / DELUSIONAL / SLANDEROUS and were subsequently withdrawn by POLICE PROSECUTIONS ON 14 JULY 2020.

i) Of particular concern, is that I was walking home from the supermarket @ 1143 HOURS on 8 MAY 2022 and had observed the APPLICANT within INTERIM ORDERS as **CASE NUMBER L10182359** issued upon 6 FEBRUARY 2020, parking their vehicle at the WATER TOWER, VICTORIA PARK near the ANGLICAN CHURCH in Cunninghame Street with the intention of keeping my driveway under observation. Within minutes of my arriving home the APPLICANT parked their vehicle in proximity to my driveway but a short distance towards the park's lake area, seemingly with an intention to effect an entrapment opportunity by cause of a "FALSE ALLEGATION OF PROXIMITY AND ACCOSTING" scenario.

ii) Such is a reasonable conclusion given shortly thereafter at @ 1200 hours in driving my vehicle so as to report the matter to police, I did a circuit of the garden precinct and noticed that the APPLICANT was again parked within an irregular manner at the WATER TOWER and alighted from their vehicle in observing the STATUE / MY DRIVEWAY area. This necessitated my making an APPLICATION for RECIPROCAL ORDERS as **CASE NUMBER N10938554** which was determined on 17 MAY 2022 and rejected on the grounds that such "STALKING AND ENTRAPMENT" opportunism might constitute prohibited behaviour when an INTERVENTION AND PERSONAL SAFETY ORDER is granted, but in and of itself is not the sufficient adverse behaviour for the granting of ORDERS.

iii) That such MODUS OPERANDI action *involving the #449 - SAINT PATRICK'S DAY UNVEILING AS IMPOSITION OF AN IRISH REPUBLICAN CAUSE THAT WAS UNRELATED TO ANY STATE / FEDERAL GOVERNMENT APOLOGIES* might be more properly characterised as being obsessive and fixation behaviour which is substantiated by the earlier circumstance on SATURDAY 21 NOVEMBER 2020, when I noticed the APPLICANT similarly moving their car around the VICTORIA PARK precinct on four occasions, being seated within the stationary vehicle as if to keep me under a continual observation whilst I attended to my various domestic needs involving several EGRESS /

INGRESS actions. In finding such malevolent intentioned conduct to be disturbing to my sensibilities as to subject me to anxiety and elevation of my agitated Post Traumatic Stress Disorder (PTSD), I then also had made an APPLICATION for RECIPROCAL ORDERS which on 13 APRIL 2021 was determined by telephone conference as similarly rejected.

**iv)** The point that I here make, is that the rejection was substantiated upon a POINT OF LAW, which then has no adverse finding against the actual nature of MENS REA / ACTUS REUS which is properly framed by the earlier events as evidence of vexatious allegations involving "FALSE PROXIMITY AND ACCOSTING SCENARIOS" being then mischievous claims of "THREATENING CONDUCT" upon **#14 - 28 MAY 2018** which was refuted by AUDIO RECORDINGS and a FAILED ENTRAPMENT EVENT of 17 SEPTEMBER 2018 which had transpired at a distance of 80 metres. Both events were attended to by POLICE and they took no further action due to evidence to the contrary.

**v)** But most importantly, there is no mention within the grounds for seeking orders as **CASE NUMBER L10182359** of this significant **NUMI / NUMEN AUGUSTI [#38, #71, #14]** context entirely relevant to claims of **INTELLECTUAL PROPERTY THEFT** as factually our only direct interactive speech event:

**#38 - 8 JUNE 2017 AS #449 - STATUE PLAQUE EVENT,  
#71 - DOMINION AS SOLDIER CULTUS OF THE IMPERIUM / BOER  
WAR MEMORIAL DAY 27 MAY 2018 AND ANZAC DEFAMATION BY  
CONTRADICTION WITH THE ODE TO THE FALLEN AS VERSE 1  
LINES 1-4,  
#14 - 28 MAY 2017 AS BOER WAR MEMORIAL EVENT**

**DOLF:** "Yes. Yeah. The problem is that with the BOER WAR Memorial on the 31 MAY ..."

**ARTIST:** "Yes"

**DOLF:** "... I hugged a mother [at] refusal of Communion at Saint Patrick's Cathedral in Melbourne on [PENTECOST SUNDAYS OF] 31 MAY 1998 [and 11 JUNE 2000 as prior to the RED MASS (signifying the Holy Spirit and therefore has a DAY OF PENTECOST manifest affiliation) WAS ARRANGED ANNUALLY BY MEMBERS OF THE MELBOURNE CATHOLIC LAWYERS' ASSOCIATION, WHICH WAS FORMED IN 2001]."

**ARTIST:** "Really."

**DOLF:** "And she was refused communion because she was wearing a rainbow sash."

...

**DOLF:** "I'm against this because I happen to be JEWISH and ..."

**ARTIST:** "Oh okay my darling yes..."

**DOLF:** "And this is a MARION statue. Now if you really want to IRISH persons its the WASHER WOMAN that was the person who was most ..."

**ARTIST:** "No no..."

**DOLF:** "The WASHER WOMAN in IRISH society was subject to more impunity than any other woman within IRISH society."

**ARTIST:** "But you know it's interesting that you say that you're um ah ... JEWISH because the man [**probably a reference to local federal minister DARREN CHESTER**] that led this through the COMMONWEALTH games ... through the COMMONWEALTH government was JEWISH."

**DOLF:** "Yes but he should know better we don't ... they don't allow statues in their TEMPLE precinct. And the circumstance that we have is that I'm of DUTCH heritage and the [INTERNATIONAL] KNIGHTS TEMPLAR which was formed in 2015 are associated with the ORDER that [DUTCH EXPLORER] DIRK HARTOG (*of note the **FEDERAL GOVERNMENT APOLOGY OF 25 OCTOBER 2012 is a JUXTAPOSITION against such DUTCH recorded discovery of 25 OCTOBER 1616***) signed the PEWTER PLATE with. So if you want to talk about erections [of commemorative merit] DIRK HARTOG signed it as AO and their were **\*SEVEN\* \*PAPAL\* \*BULLS\*** associated with my INTELLECTUAL PROPERTY.

**NOTE:** Further philological historical research has determined the AO is an abbreviation for ANNO: The implication being that this DUTCH land was subject to **RULE OF #111 = [#38, #33 [= #71 - DOMINION], #40 - LAW / MODEL] LAW** by prior discovery and fallow possession since VAN DIEMAN'S LAND was named after a GOVERNOR GENERAL as never terra nullius, accordingly we will not allow IRISH / CATHOLIC REPUBLICANISM as ANZAC (1914-1920) ATLANTIS PHANTASM JINGOISM by a **NUMEN AUGUSTI #123 = [#38, #71, #14] SCHEMA** to dispossess (ie. **presence of mind is not the same as presence of being**) any other's SOVEREIGN claim.

**ARTIST:** "So why are you against this? Why are you going to bring this into your argument?"

**DOLF:** "Because WOMEN'S SUFFRAGE was the RIGHT of the exercise of VOLUNTARY WILL in political life and this [statue] is not."

**ARTIST:** "What do you mean?"

**DOLF:** "This is not."

**ARTIST:** "What do you mean?"

**DOLF:** "Women in IRELAND have just been [granted the right of ABORTION] ..."

**ARTIST:** "No no hang on a moment.."

**DOLF:** "Women in IRELAND ... this was put here on SAINT PATRICK'S DAY of all people. Of all places."

**ARTIST:** "But I chose that."

**vi)** The legal culpability question upon PAPAL INFALLIBILITY which arises in relation to the KNIGHTS TEMPLAR which was reformed on 11 APRIL 2015 by a declaration of **PAPAL BULL \*MISERICORDIAE\* \*VULTUS\*** FOR INDICTION OF THE EXTRAORDINARY JUBILEE OF MERCY (ie. *from #355 - 8 DECEMBER 2015 (Feast of the Immaculate Conception) to #355 - 20 NOVEMBER 2016*) as then a rescinding of their formal dissolution by **PAPAL BULL \*VOX\* \*IN\* \*EXCELSO\*** dated 22 MARCH 1312 which effectively removed all PAPAL SUPPORT for them and the REVOKING OF THE MANDATES given by previous popes in the 12th and 13th centuries.

Specifically, whether the "REVOKING OF THE MANDATES" (ie. *viam provisionis et ordinationis / the way of provision and ordination*) such as the retention of "ALL SPOILS FROM CONQUEST OF WAR" previously granted by **PAPAL BULL OMNE DATUM OPTIMUM** (latin for "Every perfect gift") issued by POPE INNOCENT II on 29 MARCH 1139 that endorsed the Order of the Poor Knights of Christ and of the Temple of Solomon (Knights Templar), in which the Templar Rule was officially approved, and papal protection given.

On 2 MAY 1312, in the **PAPAL BULL AD PROVIDAM CHRISTI**, CLEMENT V assigned the order's property to the KNIGHTS HOSPITALLER except for lands and movables which were reserved for future action.

Four days later, on 6 MAY 1312, in the final public session of the Council, CELEMENT V issued the **PAPAL BULL CONSIDERANTES DUDUM**.

Being then the consideration on the nature (ie. ***Had the order not been abolished, CLEMENT could not have issued those BULLS, which finally determined the fates of the Templars and their wealth***) as any specific revocation of **PAPAL BULL OMNE DATUM OPTIMUM** and consequence to a power as retention of property by proclamation of the order's suppression, was it then IPSO FACTO only by an implication of their formal dissolution or in the words of BERNARD GUI, the learned DOMINICAN INQUISITOR and historian, "reserving the persons and property of the order to the disposition and decree of the pope and the church."

That in the circumstance where the KNIGHTS TEMPLAR as renewed upon 11 APRIL 2015 are proven to have engaged within domestic terrorism such as by imprimatur given for the CHRISTCHURCH massacre of 15 MARCH 2019 or evidence of WAR CRIMES evinced by the KNIGHTS TEMPLAR as a ROMAN CATHOLIC MILITARY ORDER engaged within a SEDITIOUS CAUSAE COMMUNI of IRISH REPUBLICAN ACTIVISM associated to the HIJACKING of the ANZAC 2018 CENTENNIAL on behalf of the CHURCH is it then sufficient cause for the forfeiture of all CHURCH property?

6) In support of this view is the **#264 - \*KEY\*** observation relevant to the CATECHISM OF THE CATHOLIC CHURCH in further making **TEMPORAL REFERENCING** to then improperly assert a **#368 / #383 - \*CHRISTOLOGICAL\* \*FIDELITY\* v's \*PRONOUNCEMENT\* \*ON\* \*SEXUAL\* \*PROCLIVITIES\* \*INFIDELITY\*** dynamic as evidence of **INTELLECTUAL PROPERTY THEFT** as **SEPTET INTELLECTUS** then hosting the **HETEROS PROTOTYPE NOUS #33** with computed and referential **IDEAS [#368 - chămiyshîy (H2549): \*5TH\* \*ORDINAL\* \*NUMBER\* / #383 - shûwb (H7725): \*APOSTATISE\*]** which by strategic locus appears to then relate by **NUMI / NUMEN AUGUSTI [#38, #71, #14]** to the **#71 / #44 / #449 - SAINT PATRICK'S DAY 17 MARCH 2017** unveiling of the **#449 - CHERISHED / BLESSED MOTHER WITH NAKED CHILD STATUE**, the **#38 - 8 JUNE 2017 PLAQUE PLACEMENT / CARDINAL GEORGE PELL'S BIRTHDAY** thereon and the **#368 / 383 - \*OVERTURNING\* / \*TURNING\* \*AWAY\*** action by an observed infidelity of a POPPY WREATH placement at the **BOER WAR MEMORIAL** in disregard to the designated date of COMMEMORATIONS to be held the SUNDAY prior which occurred on **#14 - 28 MAY 2017** / in recognition of the **COMMONWEALTH** as bestowed power / authority being the product of **CAESAROPAPISM**, but rather as conformity to **PENTECOST SUNDAY 4 JUNE 2017** and the **ECCLESIASTICAL CALENDAR** in submission to **PAPAL AUTHORITY** as **#297 / #333 - VATICAN CITY-STATE** by impetus of **IRISH**



**REPUBLICAN ACTIVISM / KNIGHTS TEMPLAR** (partisan elements with the RETURNED SERVICES LEAGUE: RSL) **RENEWED 11 APRIL 2015 (CHRIST OF THE RESURRECTION)** by declaration of **PAPAL BULL \*MISERICORDIAE\* \*VULTUS\*** FOR INDICATION OF THE EXTRAORDINARY JUBILEE OF MERCY (**ANNOUNCED: #449 - 13 MARCH 2015** with a **DURATION** from **#355 - 8 DECEMBER 2015 (Feast of the Immaculate Conception)** to **#355 - 20 NOVEMBER 2016**).

That on 23 NOVEMBER 2017 as before being served those ORDERS as **CASE NUMBER H13214018** whilst seeking medical attention within hospital due to the RESPONDENT's unreasonable action, as without any justifiable cause excepting to reinforce those previous actions, then exiting their premises with an intentional #491 - RUSHING UPON ME / HARANGUING / PSYCHICAL (PHYSICAL) ASSAULT resulting within a broken tibia and fibula and an incapacity to drive a motor vehicle until 25

JANUARY 2018.

We would add that the explicit reason given by CONSTABLE ALICE D'ARCY as steadfast unwillingness to take any witness statements in relation to an "**ASSAULT EVENT OF 23 NOVEMBER 2017 AS UNREASONED #491 - RUSHING UPON, TUMULT AND ASSAULT RESULTING IN A BROKEN LEG**" was due to my preliminary complaint statement containing what she considered to be "RELIGIOUS ELEMENTS".

**11)** The quintessential issue is an identified embracing of a **CHRISTOLOGICAL (eg: EUCHARIST) AND METASCHEMA OF EVASION WITH PARADIGM EQUIVALENCE TO FASCIST IDENTITY** (ie. **the BIPARTITE @1 - SOVEREIGN AUTONOMY DYNAMIC / @5 - STATE AS ITS INVENTION**) by the VATICAN CITY-STATE (**#291, #297, #333**) accompanying an implicit association of the **CHI-RHO (\*A\* - \*Ω\* / \*ω\*) SYMBOL** with an action of UNION / MARRIAGE by REICH CONCORDAT OF 20 JULY 1933 that has never been annulled.
